This is a new route for the YRE in Seguin. Thank you to Joe and Holly Dibrell for plotting the route for us! The walk includes Starke Park, the Walnut Springs Hike and Bike Trail, the Pecan Bottom Trail, downtown Seguin, and the Memorial Rose Garden among other points of interest.

After being featured, this YRE will begin at the Seguin Public Library on 313 W Nolte St. and will be available as both a physical walk box (PSB) and an online start box (OSB).

ELIGIBILITY/TYPE OF EVENT: Noncompetitive. Walk, jog or run at your own pace. It is open to all and families are encouraged to participate. Children under age 12 must be accompanied by an adult. Everyone participating **MUST** register and carry a start card and turn it in at the **FINISH**. There is no pre-registration.

FEES: The fee is \$4.00 for all participants. There are no refunds.

STARTING POINT: Small Pavilion P10 across from Irvine-King Pavilion, 1412 River Dr. E, Seguin, TX 78155 in East Starke Park.

START AND FINISH TIMES: 8:00 a.m. to 10:00 a.m., finish by 1:00 p.m.

DISTANCES: 10k/5k walks. The 10k route may be walked twice on the same start card for 20k Distance Credit.

TRAIL: The walk routes are on downtown sidewalks and paved park paths. The trail is mostly flat. It is suitable for strollers. The Trail Rating is 1A.

WATER & RESTROOMS: Water and restrooms are available at the start/finish as well as snacks.

MISCELLANEOUS: You may bring your leashed pet and you must pick up after it. This event will be held regardless of weather conditions.

DIRECTIONS TO START POINT: From **San Antonio** take I-10 E to US-90 E, exit 603, in Seguin. Take HWY 90 Alt E/W Court St. Turn right on S Guadalupe St. Slight right on TX-123 BUS S/S Austin St. Turn right and continue on S Austin St. Turn right on River Dr E and left to stay on River Dr E. **Pavilion 10** is on the left across River Dr. E from the large Patricia Irvine-King Pavilion.

From **Austin** take I-35 S to San Marcos, exit 204 in San Marcos. Turn left on HWY 123 (south) to Seguin. Slight right on TX-123 BUS S/N Austin St. Turn right and continue on S Austin St. Turn right on River Dr E and left to stay on River Dr E. **Pavilion 10** is on the left across River Dr. E from the large Patricia Irvine-King Pavilion.
